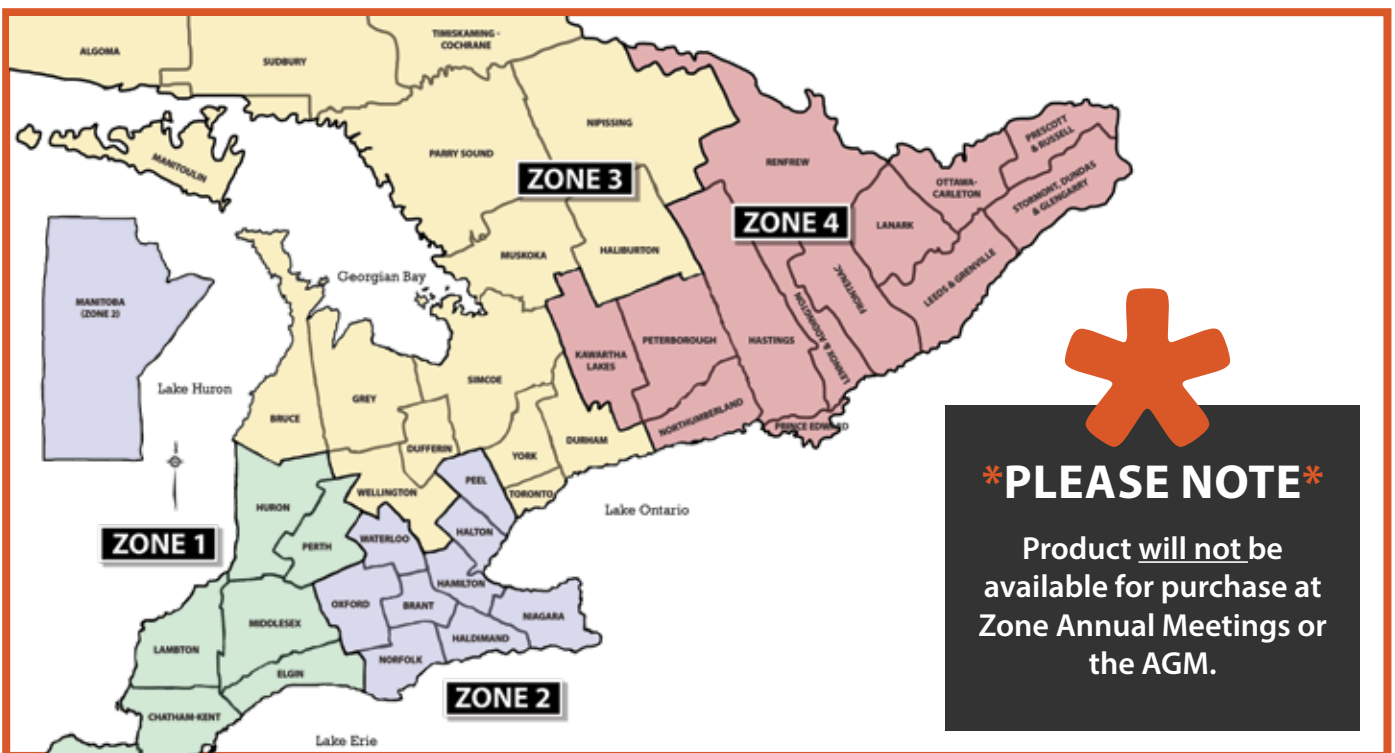
AT-LARGE DIRECTOR ELECTIONS
