**DESCRIPTION**

Gay Lea Foods Co-operative Ltd. realizes the significant value received from an agricultural-based degree or diploma. In recognition of this value, Gay Lea Foods Co-operative Ltd. is awarding six Academic Scholarships of \$500 each on a one-time basis with no financial need considerations.

**ELIGIBILITY REQUIREMENTS**

1. All ***dependent*** children of Gay Lea Foods shareholders are eligible to apply. Shareholders must be in good standing at the time the scholarship awards are announced in the fall of 2022. Children of Gay Lea Foods employees are not eligible.
2. Eligible applicants must have completed or are in their final year of high school and be accepted for admission to an accredited college or university beginning the Fall of 2022 or Winter of 2023.
3. If any successful scholarship recipient does not attend in the fall or winter for any reason, he/she will forfeit the scholarship to allow another student to take advantage of the program.

**BASIS OF AWARD**

- *First priority is given to students entering agriculture-related fields of study.*
- Demonstrated past and current involvement and leadership in the agricultural community.
- Demonstrated past and current community and co-operative involvement.
- Best average of any six Grade 12 Courses (to be used as a final determinant, if required).

Complete the attached application form and return it along with a copy of your final high school transcript (indicating average of any six Grade 12 courses) to the Gay Lea Foods Corporate Secretary ***no later than Thursday, September 8, 2022.*** *Documents received after this date will not be accepted.*
